

### WHERE IS 'YOUR MERTON'?

It's in our parks and green spaces, and on our high streets, according to the council study completed last summer. Billed as the biggest conversation Merton council has ever held, it included thousands of people who live, work or study in Merton, with the aim of understanding their views, experiences and ambitions for the future of their area.

This is very much a place-based study, focussing on the ward or neighbourhood where people live, rather than the borough as a whole. At this level the two assets people value most highly are their parks and open spaces, and the sense of community where they live. The two things they dislike most are the congestion caused by high volumes of traffic, and the perceived increase in litter and anti-social behaviour. Their wishes for the future include a revitalisation of the high street to make it a more community focussed space – less shopping, more socialising.

Those who live in Merton Park will have little difficulty in recognising and endorsing these values. Merton Park Ward is ranked first for social capital (= community cohesion) among the borough's twenty wards. Our three parks - John Innes Park, Mostyn Gardens and Kendor Gardens - are popular and well supported by their "Friends" groups, and our grass verges will be alight with daffodils when spring comes, thanks to the efforts of the many volunteers who have planted bulbs in their roads.

Revitalisation of the high street has been a long time coming as far as Morden is concerned. Regeneration of Morden town centre has been under discussion for 20 years, but the financial difficulties of TfL as a joint partner with the council and major site owner make this prospect as remote as ever. So revitalisation will depend on more immediate initiatives such as "meanwhile" uses for empty premises, greening opportunities like parklets, and better signage to take visitors beyond the centre and into two of the borough's best open spaces, Morden Park and Morden Hall Park. Like all our high streets, Morden needs a town centre manager whose role will be to promote the independent businesses on which the vitality of the high street depends.

If Morden town centre is to engender a sense of civic pride and ownership amongst residents and users, it will need more than a superficial makeover. Each of Merton's five town centres has a unique history that is too easily obscured by transitory businesses and tatty shopfronts. This historical legacy needs to be surfaced and put on display to differentiate Morden from other town centres, and give depth to its character. So the award of £35,000 to Merton Heritage for its project "There's More to Morden" is good news. The project will use shop window displays and orientation panels to highlight local history, and create heritage trails linking the town centre to residential areas and parks.

But if we widen this out to the bigger picture of the borough as a whole, we are bound to ask – is this enough? The findings from "Your Merton" are intended to serve as the basis of a strategic vision for Merton through to 2030. Can an approach based on our parks and open spaces and the rejuvenation of our high streets address inequalities between east and west that have been made worse by the pandemic? Is it just a snapshot taken at an exceptional moment in time, or does it offer a durable path to the future?

Answering these questions is the challenge that Merton Council must address as it formulates its strategic plan for the years ahead. As your Independent councillors, we will be working to ensure the views of Merton Park residents are taken into account in the planning process.

### MPWIR MOTION HELPS COUNCIL TO 'GET SMART'

As Independent councillors our remit is very simple; to represent the views of our residents, even if we may not always entirely agree with them. We tend to do this backstage, via the committees we sit on, or simply by direct action.

We rarely put forward motions, but after sitting quietly in council for three and a half years I recognised that far too often motions rarely affect anything, they are often simply political point scoring. Because motions usually have a political tone, they are amended, watered down or kicked into the long grass, understandable when such motions lend themselves more to tweets and election leaflet headlines than to action. Beyond the meeting there is no accountability.

Therefore, at the last council meeting I saw an opportunity to improve accountability and ensure that all parties can more effectively represent their residents' interests. The idea was simple; a proposal would be made that all future motions should be based on SMART goal principles, which could then be held to account. SMART stands for Specific, Measurable, Achievable, Relevant and Time-Bound.



Your Independent councillors were unsure how this proposal would be received. However, there were no suggested amendments nor indication

of opposition from the other parties in the leaders' pre-meeting and I was delighted when the motion was passed unanimously. All parties agreed that, where possible, future motions would be based on SMART goal principles and that an annual update would be sent to councillors reporting the progress made on the motions passed in the previous year. This allows further scrutiny and accountability of the council, as well as, one hopes, celebrating achievements and the opportunity to query how best to make ideas happen for the good of our residents.

While this may not be the most exciting or headline grabbing news to report, I am hopeful that it is one that can effect real change. As we go into the local elections in May, I would hope that our residents recognise that Merton Park Independent councillors get things done because we work with the administration, rather than focusing our efforts on trying to become the party in power.

### PEEL HOUSE CAR PARK CLOSUIRE

Merton Park councillors were the first to break the news that the Peel House car park which serves Sainsbury's Morden would close on Monday  $24^{th}$  January for urgent investigatory work into its structural condition. Initial estimates are that repairs will take 3-6 months.

Clearly a car park that is unsafe must be closed, but this is a major blow to Sainsbury's, which has served the residents of Merton Park well over the years, especially those who prefer its familiar aisles to the wide-open spaces of the Colliers Wood store. Peel House is the only conveniently sited council car park for centre of Morden.

The suggestion that Sainsbury's shoppers can use the York Close car park as an alternative is frankly ludicrous, and we will be pressing Parking Services to regain use of the Kenley Road car park for shoppers, now that its use as a Covid testing centre is declining.

Looking beyond the effect on Sainsbury's, this closure is a setback to our ambitions for the revitalisation of Morden town centre. The council has set aside significant funds for Morden (£200,000 for improvements in 2022/23 and £2m in matched funding for each of the next three years), and we will work hard to ensure this money is spent well. But let's get the little things right first – like a town centre with adequate parking for residents who want to shop locally and support their own High Street.

### **LOCAL ELECTIONS 5TH MAY 2022**

At the end of December, the weekly Covid infection rate in Merton Park was 1896.6 per 100,000 (150 cases). This may fall as rapidly as it has risen, but you can make sure of your vote for the local elections in May by registering for a postal vote now. This will avoid the need to visit a polling station in person.

To register for a postal vote, simply go to the council website (<a href="www.merton.gov.uk">www.merton.gov.uk</a>) and enter "postal vote" in the search box to download the application form. If you do not have internet access, ask one of your councillors to get the form for you.

The last date to apply in time for the local elections is **Tuesday 19<sup>th</sup> April.**
